

Ranvet + Equissage Competition 2019 (“Competition”)

Terms & Conditions

1. This Competition is being organised and managed by Ranvet Pty. Limited ABN 30 001 606 033 of Unit 10, 10-12 Green Street, Banksmeadow NSW 2019, Australia (**‘Ranvet’**) and Australian Therapeutic Solutions Pty Ltd ABN 89 627 762 396 of 29 Resource Street, Parkinson QLD 4115, Australia t/as Equissage Therapy (**‘Equissage’**) (jointly the **‘Promoters’**).
2. Participation in the Competition constitutes the entrant’s acceptance of these terms and conditions. Entries must comply with these terms and conditions to be valid.
3. Entry is open to Australian residents aged 18 years or over who own or manage 1 or more horses. Employees of the Promoters and their immediate family members are ineligible to enter.

How to Enter

4. The Competition commences on 1 August 2019 at 9:00am (AEST) and entries close on 30 November 2019 at 11:59pm (AEST) (**‘Competition Period’**).
5. To be eligible to enter the Competition entrants (**‘you’** or **‘Entrant’**) must be:
 - (a) an Australian resident;
 - (b) aged 18 years or over; and
 - (c) the owner or manager of 1 or more horses.
6. To enter into the Competition, you must, during the Competition Period, complete the entry form on the Ranvet website by providing a response in each of the nominated fields (**‘Registration’**).
7. The winner (the **‘Winning Entrant’**) will be chosen electronically at random by the Promoters.
8. Each Entrant may enter this Competition only once.

 - (a) 10 Bonus Entries for all Entrants who register and receive a complimentary Equissage Treatment Demonstration from an Authorised Equissage Consultant during the Competition Period via the website link provided by email to each Entrant upon Registration. If a consultation time is not available before the competition closure date, a confirmed booking demonstration date will still qualify entrants for 10 bonus entries;

- (c) 5 Bonus Entries for all Entrants who purchase a Ranvet product from 1 October 2019 to 31 October 2019 and who have their receipt confirmed by the Promoters, which will occur after the Entrant either uploads a copy of their receipt to the link available within an email that will be sent to all Entrants on 1 October 2019 or emails their receipt to info@ranvet.com.au from 1 October 2019 to 8 November 2019 11:59pm (AEST); and
- (d) Entrants will receive 1 Bonus Entry for sharing the Competition via social media and email during the Competition Period.

The Prize
