SECTION 11 TOXICOLOGICAL INFORMATION

Information on toxicological effects

Inhaled	Persons with impaired respiratory function, airway diseases and conditions such as emphysema or chronic bronchitis, may incur further disability if excessive concentrations of particulate are inhaled. If prior damage to the circulatory or nervous systems has occurred or if kidney damage has been sustained, proper screenings should be conducted on individuals who may be exposed to further risk if handling and use of the material result in excessive exposures.				
Ingestion	The material has NOT been classified by EC Directives or other classification systems as "harmful by ingestion". This is because of the lack of corroborating animal or human evidence. Vitamin E, a fat-soluble, easily absorbable vitamin, stored in the liver, adipose tissue and muscle, as well as, acts as an antioxidant and free radical scavenger in lipophilic environments, may cause skin rashes and gastrointestinal irritation. It may also present with. Other nonspecific adverse effects such as fatigue, muscle weakness, delayed wound healing, headache and decreased levels of tri-iodothyronine and thyroxine.				
Skin Contact	The material is not thought to produce adverse health effects or skin irritation following contact (as classified by EC Directives using animal models). Nevertheless, good hygiene practice requires that exposure be kept to a minimum and that suitable gloves be used in an occupational setting.				
Eye	The material may be irritating to the eye, with prolonged contact causing inflammation. Repeated or prolonged exposure to irritants may produce conjunctivitis.				
Chronic	Long term exposure to high dust concentrations may cause changes in lung function i.e. pneumoconiosis, caused by particles less than 0.5 micron penetrating and remaining in the lung. Vitamin E has been shown to cause life-threatening adverse effects in premature infants, including sepsis and necrotizing enterocolitis (inflammation of the bowel with necrosis). Ascites (swelling in the abdomen), enlargement of the liver, and loss of platelets have also occurred, sometimes resulting in death. One study has shown that alpha-tocopherol at sufficient doses (50mg/d) can greatly increase the risk of subarachnoid haemorrhage in male smokers. Principal routes of exposure are by accidental skin and eye contact and inhalation of generated dusts.
